



Addressing the ground breaking ceremony on Tuesday May 10th, for the US\$380 million (EC\$1.26 billion) project, Dr. Anthony said the new five star resort and international convention centre will provide a quality product and put Saint Lucia at the upper end of the tourism market. ccording to the recently released 2004 Report of East Caribbean Financial Holding Company Limited (ECFH), the year under review was a highly successful one for the Company. The overall success of the ECFH Grouping was in large measure due to the performance of its subsidiaries. The Bank of Saint Lucia, which is a major subsidiary of the ECFH Grouping recorded improvements in many facets of its operations during 2004.


Corporate and Development Banking

According to the Report in the area of Corporate and Development Banking, the Unit responsible for that aspect of the Bank's operations administered 170 loans with balances aggregating \$239.9 million as at December 31, 2004. This represented an increase of \$19.2million or 8.7% over the comparative figure of \$220.7million in 2003. Growth within the Tourism Sector of \$11.8million or 68% over the figure of \$17.3million over the same period was principally responsible for that development. Foreign Currency Loans to the Tourism Sector also recorded sharp increases to \$27.6million from \$10.5million over the comparative period of 2003.

Due to the Bank's increased vigilant in terms of asset quality and the strengthening of its mechanisms to monitor delinquent loans, the level of non performing loans was reduced to \$43.9 million from \$54.8million in 2003. In 2003, this figure accounted for 25% of the outstanding portfolio balance as against 18% in 2004. In keeping with the Bank's commitment to create a stronger financial indigenous institutions and market in the Eastern Caribbean, it accepted the invitation extended by the Eastern Caribbean Central Bank initiative to strengthening the region's development finance institutions (DFI). The Bank as a member of the DFI Enhancement Committee will be expected to share in the responsibility for the establishment and implementation of a programme for upgrading and capacity building within these institutions.

The Report also indicated that improvements were registered in terms of the development loan portfolio which refers to loans made to and in support

Dr Anthony added that the partnership between the Irish investors and the people of Saint Lucia was rooted in shared democratic traditions, excellence in literature and the fight by both people of both countries to create the prosperity they now enjoy.

While committing Government's full support for the project, Dr. Anthony paid tribute to the Louisy family of Laborie, owners of the Sapphire estate lands for holding onto their dream that the property was best reserved for a major tourism resort. Dr. Anthony said that the family had maintained a special relationship with persons from the neighbouring communities.

Developer of the Sapphire Cove, the Irish corporation Premier Resorts has indicated its intention to ensure the cultural integrity of the neighbouring communities is maintained. Speaking at the ceremony Mr. Tom Colton, chief financial officer for corporation said "We wish to create a resort in Laborie that will integrate its culture, heritage and art and will invite the people of Laborie to participate in this. The project will have a retail value in excess of US\$600 million."

The project will encompass special features for the development of sports tourism utilizing the extensive investment in sports facilities in the north and south of the island. Mr. Colton added "With the national sports stadium only ten minutes away from the resort, this huge amenity can be used to its maximum by attracting pre-season soccer training from Europe and United States, soccer camps for the resort guests and local children"

When completed the resort will contain 1100 units of accommodation

totaling up to 3400 rooms, extensive water sports and children's play facilities, gourmet restaurants, an Olympic size swimming pool, an eighteen hole golf course and a delegates conference centre capable of holding up to four thousand persons.

Member of Parliament for Laborie, Hon. Velon John welcomed the project as "tourism with an indigenous face" stating that the resort will benefit from the rich cultural resources of the community of Piaye, the heritage attractions and amenities of the Rudy John park, Morne Le Blanc historic site, the charm of the people of Laborie and the expertise of agencies like Labowi promotions. He called on residents of Laborie and neighbouring communities to put their shoulders to the wheel,

as the quality of their lives will only be enhanced through their increased capacity to offer their services.

In attendance at the ceremony of a section of the Sapphire estate were officials of government, representatives of the Saint Lucia Tourist Board, the National Development Corporation, members of the Louisy family including former Prime Minister Sir Allan Louisy and persons form the Laborie community, and former Prime Minister Mr. Michael Pilgrim. Also at the ground breaking ceremony were Tourism Minister Hon. Philip J. Pierre; Laborie MP and Minister of Labour Hon. Velon John; and Choiseul MP and Minister of Physical Development Hon. Ferguson John; Minister of Social Transformation Menissa Rambally; Communications, Works and Public Utilities Minister Felix Finisterre, Attorney General Philip La Corbiniere and Soufriere MP Hon. Walter François..

Speaking on behalf of the Louisy family, Dr. Pearce Louisy commended the ministers of government on insightful examination of the proposal and their professional approach to the negotiations with the developers. He said this approach "seemed to impress the Irish people tremendously because very soon after we culminated a deal and things moved precipitously"

Dr. Louisy also thanked the staff of the National Development Corporation for the facilitation of the negotiations. He presented a historical sketch of the changes in ownership of the estate and the management by the Louisy family for the past ninety years providing employment for generations of families from the neighbouring communities. Among the economic activities on the estate included bay rum production,

sugar production and cattle rearing.

The wind swept 130 acre Sapphire estate is located on the south western coast of the island flanked by the scenic bays of the Laborie village and the Piaye community. The project will benefit from the recent completion of the Vieux fort to Soufriere highway which will enhance communications from Hewanorra International Airport and shorten the usually long drive to the world renowned Pitons, now a World Heritage site.

In brief remarks at the ceremony, Minister of Tourism, Investment and Consumer Affairs, Hon. Philip J. Pierre said he was delighted that in keeping with the philosophy of the St. Lucia Labour Party administration, the investment and benefits of tourism were spreading throughout the country. Mr. Pierre noted that this expansion started with the implementation of the heritage tourism programme which brought benefits to many small communities.

He added that the developers will benefit from the extensive concessions granted by the Government under the CWC 2007 incentives legislation.

Also addressing the ground breaking ceremony was Mr. Michael Chastanet, chairman of the NDC, and Hon. Fergusson John Member of Parliament for Choiseul. Mr. John called on all residents of the neighbouring communities to rise to the challenge presented by the project, optimize their skills in construction and other areas required in the development and operation of the resort. Up to 1500 persons will be employed when the resort is fully operational.

The ceremony for the Sapphire Cove resort was held a mere 22 days after Prime Minister Hon. Dr. Kenny Anthony announced in his 2005 - 2006budget address that "The project will be developed in three phases. The first phase will comprise 447 units, with the second and third phases accounting for 450 units and 280 units respectively. Approval in principle has been granted to this development, which is expected to be officially launched in May. The Government can only hope that it becomes a reality."

The Prime Minister who is also responsible for Finance, Economic Affairs, International Financial Services and Information, stated that over thirteen additional hotel projects were ongoing in Saint Lucia contributing in part to growth in that sector, which in turn provided the backbone the projected growth in the economy.



Ten years of marine management

aint Lucia's first Marine Protected Area System, the Soufriere Marine Management Area (SMMA), was officially established in July 1995. As the 10th anniversary approaches, a number of activities are being planned for the celebration, as well as a number of public awareness initiatives to highlight the successes and importance of the SMMA to the Soufriere region and the island as a whole.

The SMMA was created as a solution to the many conflicts which existed between the resource users, including fishermen, yachtsmen, divers and snorkelers, water taxis and day charter boats and those who simply wanted to enjoy the beautiful beaches in the area. The original area included the shore zone from Anse I'lvrogne to Anse Jambon, which features some of the island's most spectacular and popular sites, comprising the Pitons.

Another important objective was to guarantee the conservation of the coastal resources for current and future generations. The SMMA is recognized as an important element of the Piton Management Area, with the Pitons and surrounding terrestrial and marine area having been designated a World Heritage Site.


Following a unique process of consultation, participation, research and site visits involving the majority of the stakeholders, the 11 kilometre coastline was apportioned into various zones:

(1) Marine Reserves – consisting of the valuable coral reefs, where extractive and damaging activities, including yacht anchoring are prohibited; the reserves are now recognized as some of the best diving and snorkelling areas in the Caribbean; (2) Fishing Priority Areas – where precedence is given to fishing over all other activities; (3) Multiple Use Areas - activities that may take place in these areas include fishing, diving, snorkelling and other recreational activities, under the guidance of existing regulations; (4) Recreational Areas – these are terrestrial (beaches) and marine (swimming and snorkelling) areas, which are reserved for public access and recreation; (5) **Mooring Sites** - these areas provide anchorage for local and visiting yachters and recreational boaters to avoid damage to the bottom substrate.

The marine reserves and fishing priority areas are delineated with signs on shore and with demarcation buoys at sea

An important aspect of the SMMA is that it is financially self-sustaining through the collection of yacht mooring, diving and snorkelling fees. Marine Rangers administrate the collection of fees as well as provide security and regulation enforcement for the area.

As testimony to its effectiveness, a number of accolades and awards have been given to the SMMA, including the 1997 British Airways Tourism for Tomorrow IUCN Special Award for

Youth Enterprise Development Fund takes off!

hirteen young people will undergo a thirty hour Personal Development Training Programme from Friday May 13th through to Sunday May 15, 2005 as part of the first segment of the Youth Enterprise Development Fund (YEDF).

The Youth Enterprise Development Fund which is being funded by the Commonwealth Youth Programme CYP and the Government of Saint Lucia is being implemented by the James Belgrave Micro Enterprise Development Fund BELFUND with assistance from the National Skills Development Centre NSDC.

According to the Manager of BEL-FUND Mr. Marcellus Joseph, the Personnel Development Training Programme is designed to assist entrepreneurs to acquire the knowledge and skills which will aid in their personal growth and development. "At the end of the programme participants should be able to improve their understanding of self and others with whom they have to interact; understand the impact of human growth and development on behaviour and personality; acquire tools for visioning, goal setting and good leadership and acquire knowledge and skills for family life improvement."

Following this initial training, participants will undergo a ninety hour business management training programme which is expected to commence on Tuesday May 17th. "The aspect of the training which include topics such as Entrepreneurship and Income Generating Activity, Managing Money and Savings, Feasibility Study, Marketing and Selling Techniques and Managing

People and Customer Relations, is to instil and/or sharpen the business management skills of participants, in an effort to sufficiently prepare them to operate their own micro businesses in an effective and efficient manner, towards achieving sustainability and profitability." Mr. Joseph said.

It was during his 2004/2005 Budget Presentation that Prime Minister Honourable Dr. Kenny Anthony articulated the need for greater social participation by youth of the society. The Prime Minister said that government also recognised that social participation without economic enfranchisement is a rather hollow ideal. "Thus we approached the Commonwealth Youth Programme to secure a portfolio of resources to specifically target young people between the ages of eighteen to thirty years, allowing for interventions that would permit them to engage in viable economic ventures," explained Dr. Anthony.

The Commonwealth Youth Programme agreed to make available a sum of twenty thousand pounds sterling (£20,000) or approximately \$94,000.00 to launch a new Youth Enterprise Development Fund. This, according to Dr. Anthony, is a modest

start, but once established it is expected that more resources will be directed to the Fund. "The Belfund shall be used as the window through which we shall collaborate with the Commonwealth Youth Programme in managing this Enterprise Fund. We expect the Youth Enterprise Development Fund to have a number of positive effects on the communities throughout the island. For instance: (1) There will be more opportunities for disadvantaged youth to create their own enterprises and acquire new skills. They will be so empowered as to be able to participate in more social, economic and political activities; (2) As more young persons gain the experience of running successful enterprises, it will mean more young people becoming economic leaders in their communities; (3) Young people will have greater access to knowledge as a result of acquiring information and communication technology (ICT); (4) There will be a stronger partnership between Government, the private sector, NGOs and other organisations; (4) There will be a strengthening of the support structures for youth develop-

During the budget presentation the Prime Minister urged the private sector, NGOs and community organisations to join hands to forge a strong partnership with Government to address issues of youth unemployment, job creation and economic growth. "As already stated, the Government cannot do it all. Hence the private sector is encouraged to increase investment in the youth because by so doing, they will be investing in the sustainable future of this country." He said

Saint Lucian prison officers get training

Instructors from regional prison establishments in the Eastern Caribbean, Barbados, Trinidad and Guyana will be undergoing training in control and restraint techniques in St Lucia from 16 to 27 May 2005.

Conducted by UK Prison Service training experts Jon Collier and Mick Rayner, this course follows on from one held in Grenada in 2003. It will provide refresher training, updating of techniques, instructing skills and re-accreditation. A large group of St Lucian prison staff will also be trained in level one control and restraint skills as the participants of the course practise their instructional and teaching techniques.

The UK Government is offering this training as part of a commitment, given at the UK-Caribbean Forum in 2000, to

support reform of the region's correctional establishments. So far this year St Lucian participants have taken part in training provided for Assistant Superintendents and a joint Police/Prison Liaison course. Further courses are planned for officers dealing with female issues, security managers, management of inmate activities, prison officers with potential, staff profiling and a workshop for Visiting Justices.

Bank Refutes Secret Account Claim

he Royal Bank of Canada (RBC) has refuted claims that the National Conservation Authority (NCA) has a secret account at any of its branches here in Saint Lucia. In a letter to Prime Minister Hon. Dr. Kenny D. Anthony, area manager for the RBC in the Eastern Caribbean and Saint Lucia, Mr. Greg Gilpin Payne, said the bank is not aware of any particulars of the so called "secret account".

In a letter to Dr. Anthony, and in response to statements made in the media by former NCA chairman Mr. Antonius "Secra" Gibson that the NCA had a secret account, the RBC manager said "the bank is not aware of any account save to say that all accounts with the bank are secret so to speak as all customers accounts are covered under the Bank's confidentiality guidelines".

Mr. Gilpin-Payne added "Since we are not in a possession of the particulars of this "secret account" we are not in a position to comment on whether the teller used the bank to manage a "secret account"


Investigation of the NCA – the Bank confirms that the said cheques were cashed at the Bank but only after the bank's proper procedures were adhered to and followed. Further these cheques were never deposited into any account in the bank".

The cheques in question were cashed by persons who were employed by the NCA as confirmed by the report of the investigation.

Earlier this month Prime Minister Dr. Kenny Anthony wrote to Mr. Gibson inviting him to provide evidence to support his charges that the NCA was holding a secret account. The letter was copied to the general manager of the RBC.

The accusation by Mr. Gibson was among numerous charges leveled at the NCA during an investigation into the government agency where Mr. Gibson served as chairman. The investigation was sparked by allegations of impropriety at the NCA. Minister or Social Transformation, Local Government and Culture Hon. Menissa Rambally initiated the investigation following a formal request from former NCA chairman Henry Charles for the probe to clear his name and reputation.

Canada withdraws visa threat

anada has taken off the table a threat to re-impose visa restrictions on St. Lucia to combat the flow of unqualified persons seeking refugee status and other forms of illegal migration.

Minister of External Affairs, Senator Petrus Compton, says the Canadian authorities have decided not to proceed with the re-imposition of visa restrictions, on account of a marked reduction in the number of persons making false claims for refugee status or seeking to enter the country with illegally obtained travel documents.

Canada had threatened to re-impose visa restrictions for St. Lucia after the number of persons arriving at Canadian ports bearing illegally obtained St. Lucian passports or making false claims for "refugee" status based on false claims had reached such levels as to cause concern.

It was discovered that hundreds of citizens from several OECS member-states had been engaging in the practice. In the four years leading to 2002, the total number of refugee claimants from all the OECS member-states stood at 864, with St. Lucia registering 275 – the highest. In 2003, St. Lucia still registered the highest.

By August 2004, there were already 616 claims launched in the first eight months of that year. And by October of

that year, St. Lucia registered a total of 245 claimants.

Particularly disturbing was the situation in Grenada and Dominica, which allegedly sold "economic citizenship passports" that were purchased and used for illegal entry by nationals of other countries. In December 2002, the Canadian government re-imposed visa requirements for Grenadians and Dominicans wishing to travel to Canada.

This led to a direct appeal to the Governments and citizens of the OECS by the OECS High Commissioner in Canada, Lorraine Williams, to take steps to stem the tide of illegal immigrants and false claimants, or face the re-imposition of the visa restrictions on those from which they had been lifted.

Senator Compton, who visited Canada recently, said the Canadian authorities had reported to the St. Lucia Consulate General that there was also a marked decrease in the number of persons arriving in Canada with falsified travel documents, including passports that had been tampered with, or which were illegally obtained.

He said St. Lucians seem to be heeding the Government's call some time ago for holders of St. Lucian passports to take better care of how they secure their travel documents.

The minister also credited tighter controls and heightened vigilance on the part of the local immigration department, especially at the island's airports, where more persons have been intercepted of late.

Among the main offenders had been persons of other Caribbean nationalities who had illegally obtained St. Lucian passports and used St. Lucia as a transit base to enter Canada.

Several steps have been taken locally of late to make it more difficult to replace travel documents, such as passports and ID cards, that may have been reported "lost" ot "stolen".

One approach has been to lengthen the amount of time it takes to replace the document to allow sufficient time to certify suspicious claims.

Strengthening ties with Italy

The Italian Deputy Foreign Minister, on a tour of the region, paid a courtesy call on Saint Lucia's Prime Minister Honourable Dr. Kenny Anthony on Tuesday, May 10, 2005. He spoke of multilateral talks that would lead to increase cooperation with the

CARICOM grouping along the lines of e-government as well as bilateral discussions that could benefit St. Lucia in the field of tourism.

"We are ready to cooperate and to have much more Italian visitors here than in the past. We know from Europe that St. Lucia has a very large presence of German people and it would be nice if we could get similar figures of Italian tourists coming to your country," said Bettamino.

Prime Minister Honourable Dr. Kenny Anthony said the relationship between Italy and Saint Lucia had been longstanding and has been strengthened over the years. The arrival of the Italian Deputy Foreign Minister he noted, would allow for discussions not only on domestic and regional issues but on international issues like the reform of the United Nations and its Security Council.

Dr. Anthony said, "Italy holds a fascination for people in the Caribbean." He noted, "We must never forget that the majority of St. Lucians are Catholics and most of them travel to the Vatican in Rome for religious reasons. Therefore Italy is an important country to us and that's why we have maintained an Honorary Consul in Italy to

look after our affairs and the affairs of St. Lucia over there."

Prime Minister Anthony pointed out that discussions on boosting tourist arrivals from Italy and surrounding areas will be pursued vigorously, as St. Lucia had in the past welcomed to it's shores several high level Italian officials among them, Italy's Prime Minister Silvio Berlusconi.

OECS LEADERS REVIEW TREATY

Technical Committee has been appointed by the OECS Heads of government to Review the "Treaty of Basseterre." This process is to allow for the strengthening of the Treaty, with a view to the formation of an economic union. The Committee which comprises regional technocrats met in St. Lucia on Tuesday May 10th, 2005, under the Chairmanship of Sir Dwight Venner Governor of the Eastern Caribbean Central Bank – ECCB.

The committee is charged with shaping proposals for the consideration of the OECS Prime Ministers who will meet in Dominica next month.

The proposals will in the main fall under two broad options. The first will consider the possibility of amending the Treaty to include features and conditions that will support and sustain an economic union. The second option is to create a new Treaty of closer integration for the formation of an economic union as well as to forge closer amalgamation in other policy areas.

Communications Officer at the OECS Secretariat Mr. Kendol Morgan says as far as the Heads are concerned the Treaty of Basseterre has served well over the past 24 years. He says the political leaders intend to ensure the Treaty which brought the OECS group to life in 1981, remains a relevant and vital force in today's changing global climate.

"The heads have agreed that based on the report of a consultant, perhaps it is time to look at a new Treaty to replace the Treaty of Basseterre which reflects the times that the sub-region is in at the moment. The feeling is that the Treaty has served the region well in the past 24 years as the countries have engaged in activities related to functional cooperation but now that the sub-region is moving closer to strengthening ties economically and creating a single economic space, perhaps a new treaty to reflect this should be the way to go," Morgan explains.

The Technical Committee comprises representatives from each of the nine member states, the OECS Secretariat and personnel from the Economic Union Project directly charged with the task of creating the OECS Economic Union
